Welcome to our 45th Annual Northwestern Vascular Symposium, a notable achievement for an institutional surgical specialty meeting. In spite of the one year postponement due to the pandemic, we are excited to come together again for this education event. The 2.5 day course provides 21.25 *AMA PRA Category 1 Credit(s)*[™], maintenance of certification (MOC) credits, and a hardcover textbook authored by the participating faculty. We have brought together over 50 international experts in their respective fields of vascular care who have contributed an up-to-date written chapter that accompanies their corresponding 15-minute presentation. We recognize the educational value of this interactive experience and invite the audience to participate along with our panelists.

In addition to the CME and MOC credits, registration for the meeting includes a daily continental breakfast, lunch, refreshments, and the hardcover textbook.

We look forward to having you join us in Chicago during this festive time of year and celebrating 45 years of knowledge sharing started by the pioneers Drs. Bergan and Yao.
